041208 Construction Report: Glenda Ramsey reported on the construction projects progress. Board Members viewed photographs of the facilities.

051208 Administration Report of Student Activities and Events

051208.1 Elementary Principal – Kristen Lennon, Assistant Principal reported that the Elementary is very glad to have Debra Burge back in the office. Newsletters were distributed. On December 11th at 9:15 a.m. the 4th graders will be presenting a musical. The 2nd grade will perform on December 19th at 9:15 a.m. On December 12, HES will be hosting a Christmas Free Book Blast Day.
