2009-2010 Budget Workshop: Joy Hicks handed out very preliminary budget worksheets.

010509 The meeting was called to order by Rex Taylor, President of the Board of Trustees.

020509 Invocation was given by Billy Johnson

030509 The Oath of Office was given to unopposed board members Mike Campbell and Danny Kelton.

040509 A motion was made by Lanny Evans and seconded by Billy Johnson to cease nominations and elect Kelly Beeler as President. The motion carried. The vote 6-0.

050509 A motion was made by Mike Campbell and seconded by Lanny Evans to elect board officers as follows: Vice-President – Danny Kelton, Secretary- Billy Johnson and Assistant Secretary – Paul Bennett. The motion carried. The vote 6-0.

060509 There was no one desiring to address the board.

070509 Construction Report – Glenda Ramsey and Kevin Darnell presented an update on the ongoing phases of the construction project.

080509 Administration Report of Students Activities and Events:

080509.1 Elementary Principal: Kendra Bennett reported that Field Day was very successful. The PALS and other high school helpers did a fantastic job. Everything ran very smooth and timely. Tutoring finished up today and preparations have begun for summer school. The Sikes Senter Mall "My School's Cool" contest is closing out for this period and we are in the running to earn \$3,000. Ms. Gillis received through

Donorschoose.org, a new carpet/rug for her room. Ms. Pollan also received new equipment for the Science lab and a digital camera from US Cellular. The 5th grade toured the Jr. High and had student council elections. Mrs. Story has organized several speakers to come in and speak with students. Keeley Bullinger has organized "Free Book Blast".
