010908 The meeting was called to order by Rex Taylor, President of the Board of Trustees.

020908 Invocation was given by Mike Campbell

030908 There was no one desiring to address the board.

040908 Construction Report: Kevin Darnell reviewed construction progress.

050908 Technology Report: Erik Sanchez, Technology Director reported that technology has been updated district-wide. New wiring has been completed in the construction areas; the internet infrastructure and software has been updated. Mr. Sanchez reviewed the Parent Portal and improvements that have been made to the website.

060908 Administration Report:

060908.1 Elementary Principal – Kendra Bennett handed out the September Newsletter to board members and reviewed upcoming activities and events. Mrs. Bennett said that the Elementary had a great start to the new school year. The breakfast seems to be a hit. Parents have been great about the pick-up procedures in the afternoon. There were approximately 325 fed at the Grandparents' Breakfast. The cafeteria ladies supplied a lot of extra food, and we had several staff members help with getting it distributed to the classrooms. The 1st round of TPRI testing is approaching and preparations are being made.

060908.2 Middle School Principal – Quana West reported the school year started out smoothly. Students are getting into the routine. Enrichment Period (3rd period) is working really well. Staff is utilizing this time for accelerated instruction and for student enrichment. Teachers are opening each class period with a set of "objective" mini-lesson questions that concentrate on historically weak objectives for students by subject. By

utilizing the Curriculum Learning Cooperative and with the assistance of Mr. Clayton, the "mini-lessons" are working well. We have also had a teacher representative from each subject go to Region 9 to work with how to better use the C.L.C. materials.

Next week, Mr. Rogers will be moving into his new classroom in the science wing. It will be nice to be able to access the new wing and also have additional space for students to congregate. The new additions should create a positive student learning environment.

Football, Volleyball, and Cross Country are under way. We also had signups for U.I.L. events this week. We are going to participate in One-Act Play this year. We had 56 student sign up to participate on OAP. We are excited about the school year.

060908.3 High School Principal – Scot Clayton presented in Gary Parrish's absence. High School had an excellent start to the school year. The Teachers have an excellent attitude about the changes that have been implemented this year. The students are showing a positive attitude and the desire to do well. Math Specialist, Mrs. Essler has been going into every math class on a weekly basis and covering objectives that we are historically weak in. She is also pulling out those kids who did not pass Math TAKS as well as those who were close to not passing for math tutoring. Mrs. Essler is doing an outstanding job. Football is going strong and although we have no wins to show for it, we are improving every week and will be in good shape by the time district play starts. Lady Cat Volleyball is going strong and the varsity is currently ranked 3rd in the state in class AA. Construction is going well and if we can get the roof drain leaks taken care of we will be in great shape.

060908.4 Assistant Superintendent – Scot Clayton report that the first six weeks daily focus questions have been completed and that work has began on the focus questions for the second six weeks.

060908.4 Superintendent – Mr. McClure congratulated Scot Clayton for being elected as State Secretary for TESPA. Mr. McClure reported that the project to repair the plumbing issue at the High School/Elementary cafeteria as been addressed. The repair will be done during the Pioneer Reunion weekend.
