100110 Administration Report of Student Activities and Events

100110.1 Elementary Principal – Kendra Bennett reported that Mrs. Ryla Pollan wrote a grant and was awarded a Target Field Trip Grant allowing the fifth graders the opportunity to have an all-expense paid field trip to the Oklahoma Science Museum in Oklahoma City. The Elementary placed first and received \$5,000 in the My School's Cool Program through Sikes Senter Mall.
