- 010211 The meeting was called to order by Danny Kelton, President of the Board of Trustees.
- 020211 Invocation was given by Danny Kelton.
- 030211 There was no one desiring to address the board.
- 040211 Administration Report of Student Activities and Events

040211.1 Elementary Principal – Kendra Bennett – Distributed newsletters to board members. PTO Chili Cook-off and Basket auction was tonight and was attended very well.
