010212 The meeting was called to order by Billy Johnson, President of the Board of Trustees.

020212 Invocation was given by Lanny Evans.

030212 There was no one desiring to address the board.

040212 Administration Report of Student Activities and Events

040212.1 Elementary Principal – Kendra Bennett – Newsletters were distributed to board members. PTO Chili Cook-off and Basket Auction was a great success with lots of community donations and participation. PTO has also raised \$1,000 through December on the "Box Tops for Education" program. Thirty-five students read at least five books off the Texas Bluebonnet list and were rewarded with a pizza party. Special thanks to Mrs. Story and Mrs. Mayes for hosting this great event.
