080113 Administration Report of Student Activities and Events

080113.1 Elementary Principal – Kendra Bennett distributed newsletters which list recent and upcoming activities. Along with the new year there has been lots of goal setting and a renewed focus on campus. Middle of the year TPRI assessments are being given, and we're seeing some good progress. Meeting with teachers to discuss how to best address student needs.

080113.2 Middle School Principal – Quana West distributed a campus report to board

members. He stated that the CAT team is meeting and discussing the upcoming school calendar, enrichment activity period and the ELITE award guidelines. Student attendance has remained high considering the ongoing flu season. Mr. West commended students from his campus for participating in the Jr. Livestock Show last weekend.

080113.3 High School Principal – Gary Parrish reported that six band members competed in area band competition with Justin Caldwell being selected to All-State Band. Clayton Hoff and Joyana Zamzow attended the Optimist Club luncheon in Wichita Falls. Both are being considered to receive the Texan and Texann Scholarship. The Clay County Livestock Show ran really smoothly and our students were very successful. The attendance rate for the first semester has been really good. 080113.5 Superintendent – Mr. McClure expressed appreciation to Mr. Clayton for presenting the updated CSCOPE report. Having just returned from Commissioner's Cabinet meeting in Austin he said that the commissioner indicated that if there are any funding coming it will probably be dedicated and that the "15%" is gone, as well as the fifteen end of course exams. There is a suggested requirement to have two end-of-course exams, but realistically it will be five to seven end of course exams. The commissioner also felt that the money is available for instructional materials allotment and that accountability will be more flexible. If the accountability system is changed there is no way to have ratings for next year. Maintaining the 4×4 , but having some flexibility with it.
