080614 A motion was made by Billy Johnson and seconded by Danny Kelton to approve EIC (Local) as presented. A motion was made by Kelly Beeler and seconded by Lanny Evans to amend the main motion by striking the work dual-credit from both plans and have dual-credit weighted giving them Tier II credit. After discussion, Kelly Beeler requested to remove his

motion to amend. This action was approved by consent of the board. The original motion carried. The vote 6-0.
