Social Studies and Science test scores have improved throughout the building. TBSI Reward for third, fourth and fifth graders this six week was Silly Day. Students got to dress silly, dance to silly songs, play silly games. HES fourth graders participated in the Ag in the Classroom day which is sponsored by the Texas Farm Bureau and the Clay County Extension Agency. Red Ribbon Week provided students with lots of fun with Drug Education lessons from Mrs. Parrish in their classrooms. Fourth and fifth graders enjoyed hearing speakers on Career Day. Students and teachers are working hard preparing for the UIL Academic Meet on December 5th. We will be hosting the event his year. The Fourth Grade Musical will be on November 21st.
